October Guest Artist Nicholas Simmons



Nicholas Simmons, our October guest artist, is a “hot ticket” who comes to us all the way from the Washington, D.C. area. Simmons is one of the most exciting new artists on the watercolor scene. His large, non-traditional watercolor and acrylic paintings have earned the admiration of artists in all mediums, and are sought by collectors, public and private. Simmons is also a popular workshop artist, known for his fresh, unorthodox, and often irreverent approach. Our CWA workshop with Nicholas, “Watercolor on the Edge,” has been sold out since early in the year, a good barometer of the attention he is getting in our area too.

An accomplished guitarist, music was his first career, with occasional forays into painting commissions. In 2002 he turned to painting full time, earning accolades and name for himself as the “the bad boy of watercolor” who likes to “break the rules.” But it’s been successful rule-breaking, as Simmons was the Gold Medal winner in the NWS 2007 Exhibition (Fresh Sushi) and many more. Check out this list of recent awards: Gold Medal 2010-Texas Watercolor Society Annual Exhibition for Nassau #1:

Discount Warehouse, Gold Medal 2009-Pennsylvania Watercolor Society International Juried Exhibition for Nassau #4: Bay St. Girl; and the Gold Medal 2008-Pennsylvania Watercolor Society International Juried Exhibition for Tokyo Express. Articles by and about Nicholas Simmons include the upcoming The Artist’s Magazine (Oct 2010), where he discusses the Biennale exhibition in Shanghai, the 8-page article in l’ Art de l’ Aquarelle, Premier Issue, Summer 2009, and a 14-page article in Watercolor magazine, Winter 2009 Issue. His work was also featured in Barbara Nechis’ acclaimed book, “Watercolor From The Heart.”

The recognition keeps coming - 2010 has been a banner year for Nicholas Simmons. He was honored as the American judge for the largest watercolor exhibition in the world, the Biennale in Shanghai, in conjunction with the World Expo in China, expected to host more than 70 million visitors. Simmons and his fellow jurors judged more than 2,300 entries from all over the world; they chose 230 to hang, and gave out 15 equal awards. Among the award-winners were some names

Simmons cont.

well-known to CWA members: Mark Mehaffey, John Salminen, and Alvaro Castagnet. (All of these fine artists have given CWA workshops in the past.) As Simmons stated, "I can't describe the thrill and honor it has been to be chosen to represent the Americas as a judge and exhibitor in this landmark exhibition, the largest in the world." He also exhibited his painting, Russian Woman, as part of the show. Read all about Simmons' experience in The Artist's Magazine (Oct 2010), which is featuring his article on the Shanghai Zhujiajiao exhibition. From China, Nicholas went on to Henderson, North Carolina, leaving his wife behind to represent him at the Shanghai opening. Simmons was scheduled to be one of the instructors, along with Mike Bailey, in a weeklong painting class for 250 artists, the Kanuga Watercolor/Watermedia Workshops. (Mike came here not long afterwards and was he ever jazzed about the week and how talented Nicholas is!)

It must be a mutual admiration society, because Nicholas blogs that "one of the best parts of the week for me was getting to know Mike Bailey and Ted Nuttall, two guys who are so high on my 'faves' list, it's not even funny...Reading Mike's blog is like getting a masters in fine art - for free." Apparently, solving the watercolor

problems of the world over a bottle of Glenlivet was one of the week's activities. We'll have to hear more about that!

Nicholas Simmons is also one of the many artists taking advantage of digital technology. As Simmons describes, he uses Photoshop to explore and to expand his composition's many possibilities. "Many watercolor artists have experience using computers and programs...(with) their reference photographs, but how many can say that they've applied these tools to their paintings? Viewing your composition through the lens of a graphics editing program is a fascinating way to explore the endless possibilities hiding in your work—if not also in your head—and to stimulate new ways of thinking and seeing." But as he says, knowledge of the subject, an eye for balance and competent drawing skills are necessary in order to make decisions and corrections where technology has gone "wrong." In other words, technology can enhance, but not stand in for, aptitude and experience.

Nicholas Simmons is a force to be reckoned with the art world. CWA is very fortunate to have him as a workshop instructor and as a guest artist for the general meeting. Don't miss it!!!

from the budget director

This is just a reminder about the process of requesting checks and getting reimbursed for expenses. There are a couple of things that help the process go much more smoothly:

- When you need an advance check for any reason (show awards, payments to artists for demos, etc.), please send me an Expense Report form that is filled out with the amount needed, what the check is to be used for, who to make it payable to, and where to mail it. Mail or email me the request. This process takes a couple of weeks, so plan ahead.
- When you have incurred expenses out of your own pocket and

want to request reimbursement, please use the Expense Report form and attach the receipts to it. If you have receipts for more than one type of expense (e.g., supplies for a General Meeting and materials for a workshop), itemize those so we can keep the accounting straight.

The Expense Report form is available on the CWA website. Click on the drop down menu on the home page and go to Forms. Your help with this will be greatly appreciated!

David Savellano, CWA has earned signature membership in the National Watercolor Society. His painting “Hometown - Park & Central” was chosen for the NWS 90th Annual Exhibition at the NWS Galley in San Pedro, California from October 30th to December 11th, 2010.

Helen Sherry earned Signature Membership in the San Diego Watercolor Society following her successful entry of “Quake” in the SDWS 30th International Exhibition; the painting also received the Hedekin Award. In the Alaska Watercolor Society 36th Annual Juried Exhibit. “Life Force” was awarded First Honorable Mention; “Spring Forward” was accepted into the International Society of Acrylic Painters 2010 Exhibition, and in the July Members Juried Show of the San Diego Watercolor Society Helen was awarded Honorable Mention for “Veiled Promise”.

- ◆ Theme of ***“Reading”*** for all entries. Entries must depict reading or writing as subject matter to be eligible.
- ◆ Entries may not be smaller than 18” or larger than 48 x 50” framed.
- ◆ Original, recent (within 2 years) water media on paper, Yupo accepted. No copies or class work. Paintings must be framed in metal or wood, covered with Plexiglas, (no glass) wired and ready to hang. No saw tooth, clamps or screw eyes. Flat brackets required on wood frames. No cardboard or masking tape. No wide (over 3 inches) or Rococo frames. White or off-white mats only.
- ◆ Diablo Valley College has determined unsuitable for hanging any nudes or any subject which can be construed as being religious or political in nature.

Entry Procedures:

1. Limited to 2 entries per artist.
2. Fees \$10.00 entry fee for each painting, two submissions total, CWA members.

3. Use JPEG files only. Minimum size is 1200x1800 pixels (4”x 6”). 300 dpi is required. Images that do not meet these requirements will be rejected
