

"I paint and I dream at the same time" လြှငြေစက္ခက်က

This is the key, unless you are a photorealist painter of course. Many of us, maybe I'll be daring and say most of us, are not photorealist. Then why do we struggle so hard to paint our subjects the way we start out wanting to paint them! We paint all the foliage green. We think all tree trunks are brown. All white birds are white... STOP!

Let's try to listen to our inner Gauguin. He has something here. The painting in front of you is not a duplication of your reference photo. It is a part of your mind. It's an extension of yourself. You subtract things, you add things, you use your imagination to make your painting unique. What is the main denominator here... YOU! We are told to simplify our subject matter all the time, but do we do it? No, because we are not dreaming, we are performing a mental process of simplifying.

Do we need to "see" everything in our paintings or can we "dream" things into our paintings? Whether it is color or shape, why not dream more or less into your paintings. The painting police might be taking a coffee break and not give you a ticket for putting yourself into your work!

So, the next time you see that unusual purple tree in a painting of mine with the teal tree trunk, don't ask and I won't tell.

Eligibility

This CWA Members Show is open to ALL CWA members 18 years or older.

Paintings must be two-dimensional and primarily watermedia on paper surface; Yupo, Tyvek and Aquabord are acceptable. Pastel or collage may be used as long as watermedia is the dominant medium. Digital media, photography, prints, or reproductions are not acceptable. The source material and composition of submitted work must be wholly original and not derived from any published images. Entries must be entirely the work of the artist, and **not shown previously in a CWA Members Show**. No workshop or class work allowed. All paintings must be for sale. All work submitted to this show must have been completed in the past two years. Subject matter that may be objectionable to the public (e.g., nudity, obscenity, and extreme political/religious views) will be disqualified.

• Artists that fail to provide the accepted entry will be disqualified for one year from entering a CWA Member Show.

• Paintings shown in a previous CWA Members Show will be disqualified from this show and the member will be disqualified for one year from entering Members Shows.

SHIPPED PAINTINGS FROM ALL REMOTE CALIFORNIA AND OUT-OF-STATE MEMBERS ARE WELCOME. See Accepted Entries section on next page for more details.

Online Entries Only

All entries will be submitted via our website, californiawatercolor.org. Members may enter up to three digital images in jpeg format, resolution 300 dpi, with 1200 pixels on the longest side, one painting per file. Show <u>only</u> the image <u>without</u> mat or frame.

Log in to the Members homepage, choose Shows/Exhibitions, then Member Shows and choose Autumn's Allure. Confirm your information, add your painting details and upload your images.

Entry Fees (non-refundable)

Entry fee is payable by PayPal, credit, debit, or individual account. CWA Members: \$25 for two images, \$35 for a maximum of three images.

Accepted Entries

All accepted artists will be notified by email and results will be posted online August 17, 2019. Accepted work must match the submitted image; paintings not consistent with submitted image WILL be disqualified. The acceptance email will include all instructions for delivering the accepted painting(s) to the San Ramon City Hall Gallery in San Ramon, including a San Ramon City Hall Gallery loan agreement to sign and return with the artwork.

Please note; delivery for this show is hand-carry for those close enough to the venue to do so. To clarify this, we want to open this show to our members in other states, as well as those who are located more remotely in California to where most of our Members Shows take place in the Bay Area. Think of it this way, IF you have been in a Members Show in the past several years, and hand carried your work to deliver to the show, please consider that you are required to do so for this show. Shipping of paintings for those in California, will be allowed for those who live south of San Jose, east of Sacramento and north of Santa Rosa.

More details for shipping paintings will be in the acceptance letter. There will be a \$20 handling fee for shipped paintings.

Size Limits

Minimum image: 140 square inches, no side less than 10 inches. Maximum outside frame: 40 x 40 inches.

.

Framing

All paintings on paper, Yupo or Tyvek must be framed in simple, square-cornered frames ready for hanging and protected under acrylic (not glass). Frames **MUST** have a foam core backing, wire ends must be taped and should be ready to hang. No sawtooths, clamps or eye screws will be accepted. Mats (optional) must be white or off white. Colored liner mats are acceptable. Paintings on Aquabord (or other similar surfaced) cradled panels and varnished or finished with a protective coating may be displayed without an acrylic covering, but must still be framed in simple, square-cornered frames with wire (and D-rings) for hanging. Additional details may be included in instructions to accepted artists.

The following sentence is repeated for your *convenience*... Frames **MUST** have a foam core backing. It must show clearly that it is foam core when the painting is accepted at the show. IF you use the type of frame that has clasps that turn to close a hard board backer in place, the frame **must** have a brown paper dust cover glued to (over) the back of the frame. The masonite and hard board backing boards that come with many store-bought frames are not acceptable. The reason for this is that if someone buys a painting at one of our shows, we want them to get a product that will not discolor with age or affect the watercolor paper or surface.

Sales

All sales will be made through the San Ramon City Hall Gallery. All paintings must remain for the duration of the show. San Ramon City Hall Gallery will retain a 20% commission on all work sold. CWA will retain a 10% commission on all work sold.

Conditions and Liabilities

No work may be withdrawn before the end of the Show. CWA and San Ramon City Hall Gallery reserve the right to photograph artwork or copy images for promotional purposes. San Ramon City Hall Gallery does not provide insurance for the artwork while it is in their possession. The submission of entries to this show shall constitute an agreement on the part of the artist to the terms and conditions as set forth in this prospectus.

Encouraging the community to enjoy painting with watercolors is one of the California Watercolor Association's goals. Encouraging young people to paint watercolors is an especially high priority. So we were delighted to preview the high quality juried exhibit of 7th-12th graders at the 2019 Alameda County Fair in Pleasanton and choose the CWA award winners.

The paintings were judged by four criteria: composition, originality, color\value and title. Rating each painting by these criteria helped sort the winners from a group of fine paintings. The criteria of title helped to interpret the intention of the creator. There were some provocative titles, for example, *Morphing Is Natures Beauty, City of Colors*, and *Blank Face*.

Each winner received \$50 and CWA Youth Award blue ribbon. The winner for the 7th-8th grade category was Shawn D'Costa for his painting *watercolor*. The winner for the 9-10th grade category was Emily Har for her painting



Sky Scrapers. The winner for the 11th-12th grade category was Aaliyah Gholamipour for her painting *Night Terrors.* It was a pleasure to view these young people's paintings. See what you think of the upcoming generations' watercolors.

CWA Board Bylaws "Term of Office" Review

Your board periodically reviews the CWA Bylaws and Policy and Procedures documents. A current review of the Bylaws brought the following item to our attention:

ARTICLE V NOMINATIONS AND ELECTIONS

Section 6. Term of Office. The term of office for all Board Members shall be one calendar year beginning with the 1st day of January and ending with the 31st day of December. A Board Member may be re-elected to the same or another position on the Board. At the time that a Board Member vacates a position on the Board, that retiring Board Member shall turn over all books, papers, money, credit cards, other information and Association property to the newly elected replacement Board Member. A Board Member may serve four consecutive whole terms in the same office.


Since the Board has traditionally had difficulty fielding new Board members, Board consensus is that we should strike the last line. This change will be brought to the membership at the September 18, 2019, general meeting for a vote. All changes to the CWA Bylaws require a vote by members at a general meeting.







Venue

The Harrington Gallery, in the Firehouse Arts Center, 4444 Railroad Avenue, Pleasanton, California, features the works of renowned visual artists of regional and national stature in painting, sculpture, installations, and conceptual art. Old Fire Station Number One, established in 1888, served downtown Pleasanton well for many years. This rebuilt facility became the basis for the Firehouse Arts Center, including a portion of the original building with brick walls preserved within the gallery space. The gallery is just a few steps off Main Street in the heart of downtown Pleasanton.

- Paintings must be two-dimensional and primarily of watermedia on paper surface; Yupo and Tyvek are acceptable.
- Pastel or collage may be used as long as watermedia is the dominant element.
- No digital media, photography, prints, or reproductions. Source material and composition must be wholly original and not derived from any published images.

- Artists who fail to provide an accepted entry are disqualified from the next two CWA National Exhibitions.

- Digital jpg image of your painting, 300 dpi, no more than 1200 pixels on the longest side. Show only the image without mat or frame.

You may wish to join CWA prior to entry to save on your entry fee and to enjoy the benefits of membership. You may do this during the entry process.

Deadline for submission is midnight, September 1, 2019 - Pacific Standard Time

Framing

- All paintings must be framed in simple, square-cornered frames ready for hanging.
- Paintings must be protected under sturdy acrylic, such as Plexiglas. No glass is permitted.
- Mats (optional) must be white or off white. Colored liner mats are acceptable.
- Additional details will be included in instructions to accepted artists.
- Artists outside of the contiguous USA may send artwork unframed, and CWA will frame for the exhibition for an additional \$100 fee.

Accepted Entries

All accepted artists will be notified by email, and the selected artists will be posted online September 28, 2019. Artists with accepted artwork may be asked for a higher resolution image for the exhibition catalog. Shipping instructions will be attached to the acceptance email. All accepted paintings will have a handling fee of \$50. Accepted work must match submitted image; paintings not consistent with submitted image may be disqualified. All accepted paintings will be represented in the exhibition catalog. Each exhibition entrant will receive a complimentary catalog prior to the exhibition opening. Additional catalogs will be available for purchase.

Sales

The Harrington Gallery will handle all painting sales and retain a 30% commission.

No work may be withdrawn before the end of the exhibit. CWA and the Harrington Gallery reserve the right to photograph artwork or copy images for promotional purposes. Insurance coverage is the artist's sole responsibility, both in transit and during the exhibit. Neither CWA nor the Harrington Gallery insures the artwork and neither shall be responsible for loss or damage to any artwork submitted. Accepted artists must sign a release of liability. The submission of entries to this competition shall constitute an agreement on the part of the artist to the terms and conditions as set forth in this prospectus.

Plein Air – Meeker Slough, Richmond Saturday, August 17, 2019, 10:00am to 1:30pm




